

# **TERMS OF SERVICE AGREEMENT**

*PLEASE READ THE FOLLOWING TERMS OF USE AGREEMENT CAREFULLY. BY ACCESSING OR USING OUR SITES AND OUR SERVICES, YOU HEREBY AGREE TO BE BOUND BY THE TERMS AND ALL TERMS INCORPORATED HEREIN BY REFERENCE. IF YOU DO NOT EXPRESSLY AGREE TO ALL OF THE TERMS AND CONDITIONS, THEN PLEASE DO NOT ACCESS OR USE OUR SITES OR OUR SERVICES. THIS TERMS OF SERVICE AGREEMENT IS EFFECTIVE AS OF .*

## **ACCEPTANCE OF TERMS**

The following Terms of Service Agreement (the "TOS") is a legally binding agreement that shall govern the relationship with our users and others which may interact or interface with WebCMSNow LLC, also known as WebCMSNow, located at 3771 Suzanne Way, Redding, California 96002, and our subsidiaries and affiliates, in association with the use of the WebCMSNow website, which includes [www.webcmsnow.com](http://www.webcmsnow.com) (the "Site") and its Services, which shall be defined below.

## **DESCRIPTION OF WEBSITE SERVICES OFFERED**
